

## APPLICATION FOR SECONDARY SCHOOL BOARDING GRANT

### Information for Applicants

Please read this section **BEFORE** sending in your application to the Ngāti Mutunga o Wharekauri Iwi Trust (**Trust**).

### Type of grant available

The Trust will provide secondary school boarding grants to students of Ngāti Mutunga o Wharekauri descent to attend a boarding school or assist with private boarding while attending a secondary school.

The grants will be a \$750 contribution towards the cost of secondary school students attending a boarding school or the costs of secondary school students privately boarding while attending secondary school (**Boarding Grant**).

### Conditions of application

All of the following conditions must be met before a Boarding Grant is considered by the Trust:

1. The student who is attending boarding school or privately boarding is the applicant.
2. If the applicant is under the age of 18 the application must also be completed and signed by the applicant's parents or caregiver (unless there are extenuating circumstances).
3. The applicant must be of Ngāti Mutunga o Wharekauri descent.
4. At least one parent must be a registered member of the Trust (*application forms are available from the Trust's office or online at [www.nmow.co.nz](http://www.nmow.co.nz)*).
5. Each application must be accompanied by the following written confirmation:
  - a. in the case of a secondary school student attending a boarding school, written confirmation from the school that the student is attending the school as a boarder; or
  - b. in the case of a secondary school student who is privately boarding:
    - i. confirmation from the secondary school that the student is living in private boarding away from their parent or guardians; and
    - ii. confirmation from the private boarding provider that the student is living in their private boarding.
6. Each applicant is entitled to apply for one Boarding Grant per academic year (for the avoidance of doubt, successive applications in one year are permitted if the previous application was declined).
7. Consideration and approval of applications is in the sole and unfettered discretion of the Trust. Submitting an application which meets all valid conditions does not guarantee approval.
8. By applying for a Boarding Grant the applicant (and the parent/guardian if necessary) acknowledges that the information provided may be disclosed to members of the Trust and any third parties the Trust considers necessary to confirm the accuracy of the application (such as the relevant school or boarding provider). This includes liaising directly with third parties.
9. The 2017 funding round will close at **5pm on 30 November 2017**.
10. If accepted the Boarding Grant will be direct credited to either the school (with the money being credited to the student's account) or the private boarding provider, with the parents or guardian and the school and/or boarding provider being notified that payment has been made.
