He Tohu

The process to completion is as follows:

March 2018 – Final tohu selection.

Settlement Update

As you'd expect with an election just finished, negotiation slowed down during September and October. We're not expecting the settlement to speed up until after Christmas. We've a new Minister of Treaty Settlements, the Hon Andrew Little, and it will take time to bring the Minister up to speed.

You're no doubt aware our Moriori whanaunga have received their settlement offer. This is a positive development as it now provides us a baseline in which to set our realistic settlement amount. For example, as a part of our cultural revitalisation vision the Crown has now responded positively to the establishment of a Ngāti Mutunga pa and marae on Wharekauri. We expect this component to occur outside of the settlement as it did for Moriori with Kopinga marae.

We have set four Agreement in Principle baselines that has caught the Crown attention. These are:

1. The inclusion of Wharekauri as a 'region' in the Regional Economic Growth Program (this may have become more significant with the appointment of Shane Jones as Minister for Regional Growth and an annual budget of \$1b for that purpose).
2. A formal Infrastructure review for Wharekauri every five years from the date of settlement and commitment to implement the findings of such reviews.
3. A preference for the purchase of suitable goods and services from Wharekauri owned and based businesses when the Crown is funding goods and services as part of projects or programmes on Wharekauri.

Separate Crown funding outside of the individual iwi settlements to finance costs is to be borne by both iwi as part of



shared post-settlement responsibilities. These responsibilities include participation in the Joint Planning Committee dealing with Resource Management Act issues and responsibilities arising from the joint ownership of the bed of Te Whānga Lagoon.

Whanau we have hit a stumbling block with the Crown. Unfortunately the Crown has offered exclusive ownership of blocks of land on Wharekauri to Moriori. Our position is that such exclusive ownership is inappropriate as Ngāti Mutunga o Wharekauri has an overlapping cultural interest in all land. We are clear exclusive redress of this kind without Ngāti Mutunga o Wharekauri assent or engagement is a breach of the Treaty. We will be drawing this to the new Minister's attention as a matter of priority.

KINA ACE ALLOCATION

Request for Expression of Interest from young, development Ngāti Mutunga o Wharekauri divers

AHC currently supports 26 NMOW fishers and divers by way of ACE/catch allocations. In order to provide a development opportunity, a 10mt parcel of Kina (SUR4) ACE has been specifically set aside for a young NMOW diver. Note – AHC's limited volume of quota owned means there is no current capacity to add any paua ACE to the parcel at this time.

AHC is offering the opportunity for young NMOW development divers to submit an expression of interest for the SUR4 parcel. It is expected that those expressing interest will have previous diving experience working on other boats but are relatively new entrants in terms of running, operating and skippering their own vessels.

Expressions of interest are to be submitted to the NMOW Iwi Trust Office or emailed to ahc@nmow.co.nz and should include:

- A brief history of relevant diving experience and details of current diving operation.
- Diving career goals.
- Copies of relevant diving and vessel management qualifications.
- Vessel details including copy of the Fishing Vessel Registration.
- Copy of current Fishing Permit.
- Any other relevant details, eg – participation on fishery stakeholder groups, contribution to NMOW, etc.
